Representations and Warranties

The undersigned hereby agrees that, upon issuance of the permit, the Village of Libertyville shall not be liable for any failure of service or any consequential damages claimed from the result of the installation or operation of the undersigned’s alarm system.

The village shall take every reasonable precaution to ensure that alarm signals and prerecorded alarm messages received by the village are given appropriate attention and are acted upon with dispatch. Nevertheless, the village shall not be liable for any defects in operation of automatic protection devices and signal line systems, for any failure or neglect to respond appropriately upon receipt of an alarm from such source, nor for the failure or neglect of any person with a license issued pursuant to this chapter or with a franchise, in connection with the installation, maintenance and operation of equipment, the transmission of alarm signals and prerecorded alarm messages, or the relaying of such signals and messages. If the village finds it necessary to disconnect a defective automatic protection device or signaling device, the village shall incur no liability by such action. (Ord. The undersigned hereby agrees that any and all fees, costs, or charges for maintenance, alteration, upkeep, or repair of their alarm system, equipment, or premises shall be the sole responsibility of the undersigned, and that the undersigned shall pay all charges assessed by outside contractors for their services. As a user of an alarm system, the undersigned warrants that said system meets the requirements of all state and local building codes, as well as Chapter 3 of the Libertyville Municipal Code.

As a user of an alarm system that is related to the dispatch center affiliated with the Village of Libertyville, the undersigned agrees to abide by all alarm regulations in Chapter 3 of the Libertyville Municipal Code, as well as those detailed in this Alarm User Permit Application.

The undersigned understands and agrees that this Alarm User Permit and the service provided pursuant to this Alarm User Permit may not be transferred. Further, the undersigned shall remain liable for any costs and fees incurred hereunder until the Village of Libertyville has received proper notification regarding the transfer of property ownership and/or termination of service.
