Note: Appeals contesting the types of surface areas designated by the Village as impervious will not be considered.

Other Appeal Types

Unique Circumstances: There are unique features of, or unique circumstances affecting, the property, such that the amount of the stormwater utility fee does not approximately reflect the impact of the property on the Village stormwater system. In order to receive an adjustment, the unique features or circumstances must not be generally applicable or present to other properties in the Village.

Describe in detail the unique circumstances that may exist and the specific type of relief being requested. Please be prepared to provide additional evidence supporting the appeal upon request by Village staff. Applicants should also be prepared to show disparate impact on an objective basis with a direct nexus to stormwater conveyance.

2. Evidence demonstrating the homeowner's association's specific authority to lodge a stormwater utility fee appeal on behalf of all of its members. This documentation should include one or more of the following (if missing or unclear, the appeal will be returned without review):
 - a. Association bylaws
 - b. A resolution adopted by the association board at a duly authorized meeting
 - c. Meeting minutes
